# **Biographical note**

John Otway Percy Bland was born in Malta, second son of Major-General E.L. Bland of County Antrim, Ireland. He was educated in Switzerland, at Victoria College, Jersey, and at Trinity College, Dublin. In 1883 he joined the Chinese Imperial Maritime Customs and for some years was also Private Secretary to Sir Robert Hart, resigning in 1896 to become Secretary to the Municipality for the Foreign Settlements at Shanghai. He became representative in China of the British and Chinese Corporation Ltd. in 1906, and negotiated four railway loans with the Chinese Government. In 1910 he resigned and left China.

He had been Times Correspondent in Shanghai from 1897-1907 and in Peking, 1907-10. After his return to England he engaged chiefly in journalism. He published ten books under his own name, mainly on eastern affairs and current events.

He is chiefly renowned for his collaboration with Sir Edmund Backhouse in *China under the Empress Dowager*, 1910, and *Annals of the Court of the Court of Peking*, 1913.

Bland died at Aldeburgh, England in 1945.

# Scope note

Bland was a conservative-minded political pragmatist, believing that the commercial and military British presence in the Orient should be maintained both for the defence and economic stability of the Empire. He was however by no means terrorized by the "threat" of the Yellow Peril. He felt that American and English Church missionaries and organizations such as the Y.M.C.A. were naively and idealistically playing into the hands of the advocates of Young China, and was worried that funds supplied by them might be used by anti-Imperial elements to displace western influence in the Orient. His opinion undoubtedly developed from his own experience as an Imperial Chinese Customs official (1883); as private secretary to Sir Robert Hart; as secretary to the Municipality for the Foreign Settlements at Shanghai; as representative for the British and Chinese Corp. Ltd. (1906); as a negotiator for four railway loans with the Chinese Government; as Times correspondent at Shanghai (1897-1907) and at Peking (1907-1910); and as a journalist and traveller -- he returned to China for a visit in 1919-1920. He witnessed the effects of the Boxer Uprising, and, as an advocate of the Raj, had a very low opinion of the Kuomintang movement and the regimes of Sun Yat Sen and Chiang Kai-Shek, feeling that, although the Chinese deserved to keep their culture free from foreign influences and imported political systems unnatural to ancient tradition, they still were not capable to self-government as long as anti-western feeling was rife. Consequently he sided with the Japanese against the Chinese up to the time of the Second World War. He continued to publicise his views about political, economic, and social issues in the East and elsewhere in books, magazine articles, and public lectures. As a self-styled political realist, he foresaw the threat of Hitler's Germany, advocated birth-control, and condemned pacifism as defeatist.

His collaboration with Sir Edmund T. Backhouse of Peking on his two most famous books, *China Under the Empress Dowager* (including the apparently fraudulent 'ChingShan Diary'), and *Annals and Memoirs of the Court of Peking*, is of particular interest especially to students of the final days of the Manchu Dynasty. Backhouse~ translation (in carbon-copies and corrected holograph drafts) of hundreds of Imperial documents and decrees are to be found in the collection; much of this matter did not appear in the latter book's final text.

Bland's correspondence, extending from the 1880's to the 1940's, is very large. Among his correspondents are many of the periods best-known writers on Chinese culture, history, and politics. There are, for example, some 240 letters from Dr. G.E. Morrison,

Times correspondent at Peking after Bland's tenure there. Bland continued to stress in his letters his pragmatic anti-liberal but basically humane theories to authorities on the Orient from England, France and the U.S. There are also many letters from governmental, business, diplomatic, and customs officials in China itself, such as Sir Robert Hart, Alfred E. Hippisley, Sir James Mackay, Sir John Jordan, Edward Guy Hillier, Lord French, Sir Ronald Macleay, etc. Chinese and Japanese diplomats and political figures are also present.

There is as well in the collection a wealth of Bland's personal memorabilia relating to social life in the British settlement at Shanghai at the turn of the century. His own library was sold during his lifetime, but the Bland Papers includes a set of nine bound volumes of pamphlets on the East, particularly pertaining to China, which were formerly owned by a Dr. Jamieson; these cover the period from the mid-19th Century to the early 20th.
