The Hugh Kane Papers consist of journals, reports, notes, and correspondence on publishing in Canada from 1955 to 1981 written and compiled by Hugh Kane (1911-1984) during his career at McClelland and Stewart Publishing Company and at Macmillan Company of Canada. They include journals from his coast-to-coast business trips; correspondence with authors such as Constance Beresford-Howe, John Diefenbaker, Bruce Hutchinson, Dennis Lee, Thomas Raddall, and business associates such as Jack McClelland and John Gray; and notes and correspondence on censorship.

CHRONOLOGY

231

- 1911 September Born in Belfast, Northern Ireland, to Hugh Smiley Kane, a sea captain, and Alice Harvey Pyper; moved to Canada when he was a child.
- 1922-28 Attended Rothesay Collegiate School, near Saint John, New Brunswick, where his family lived during the winter
- 1928-1929 Worked for Sun Life Assurance Company in Montreal where his family lived during the summer
- 1929-31 (?) Lived in New York with his uncle who was an actor
- 1936 Moved to Toronto and worked for Reginald Saunders' book distributing firm
- 1937-1969 Worked for McClelland and Stewart, except for his service in the Royal Canadian Air Force, 1942-1946; in 1955 Dorothy, his first wife, died and in 1955 married Lorna Elizabeth Would; in 1955 he became vice president.
- 1962-1963 Chairman of the Book Publishers' Association of Canada
- 1963-1966 President of the Co-operative Book Centre of Canada
- 1966-1967 President of the Canadian Book Publishers' Council
- 1969-1972 President of Macmillan Company of Canada
- 1972-1976 Vice Chairman of Macmillan after MacLean-Hunter bought it in 1972
- 1973 Published Joseph Smallwood, I Chose Canada
- 1974 Published Gwendolyn MacEwen, Magic Animals; Hugh MacLennan and John Visser, Rivers of Canada; and Dennis Lee, Alligator Pie.
- 1975 Published the first volume of Our Canada, by John Diefenbaker
- 1976-1982 President and managing director, Natural Science Library, McClelland Stewart
- 1984 October Died in Stratford, Ontario
