A collection of family papers, dating from 1797, when the first family member emigrated to New York from Scotland, to the 1950s (4th generation). Includes correspondence, land deeds, aritectural plans, and other family documents. Charles S. Milne (b.1877), the son of Alexander W. Milne, married Edna Shepard Johnson in 1909. Edna (b.1880) was the daughter of Abram S. Johnson and Saida A. Shepard, of North York. The collection includes some early Johnson family papers, including a testimonial for Abraham Johnson, dated 1794.

## **Historical Note**

The earliest material in the collection are letters to and from Alexander Milne (b.ca.1777) and his brothers, Peter, David, and William, dating from 1797 to 1818, documenting their early years in New York and the eastern states. The Milne brothers emigrated from Dundee, Scotland, where they had learned the weaver's trade. Peter, the first to emigrate in 1797, and David, who appears to have emigrated in 1801, earned a precarious living at first as peddlers. David died on the road in 1804, but by 1802 Peter was living part of the time at his home at Oyster Bay on Long Island.

The third brother, Alexander, emigrated to New York in 1802, and was able to find work as a weaver, both on Long Island and elsewhere. He emigrated to Canada in 1817. Most of the papers described here relate to him and his descendants. (William, another brother, emigrated to New York in 1802. He appears to have been a sailor. Helen Milne, mother of the brothers, also emigrated, and lived at Peter's home on Long Island).

By 1823 Peter Milne had emigrated to Canada and had started a woollen mill and saw mill in Markham, apparently having made considerable money from business transactions in the United States. Alexander Milne became a partner with Peter in the operation of the mills in Markham around 1824. In 1827 Peter married and Alexander and he dissolved their partnership. Alexander moved to North York and established a mill at Don Mills and Lawrence (the site of Edwards' Gardens). He acquired the property along Lawrence from this site over to what is now Woodbine, where he moved his milling operations in 1832. This milling business, at "Milneford Mills", Wexford, is the focus of the most interesting part of this collection. Alexander operated it with his son William into the 1860s.

After Alexander's death (he was still living in 1866), William Milne continued to operate the mill with his son, Alexander W. Milne. In 1878 a new mill was erected after bad floods had damaged the previous one. Two sheets of architectural drawings for this mill, dated 1877, and signed by the Toronto firm, Langley, Langley & Burke, and a copy of their specifications for this mill are in the collection. There are also deeds and other legal documents relating to the mills and property along Lawrence, dating from 1829 to 1920. (Box 2)

After William Milne's death in 1880, Alexander W. Milne continued to operate the mills. Either he or his son, Charles S. Milne, closed the mills in the early 1900s.
