

Solandt-McKillop Collection

Solandt, André, ca. 1819-1894. Protestant missionary and colporteur of religious books in Quebec, where he moved from Alsace in 1844.
McKillop, Archibald, an "Arran settler" in Inverness, Megantic County, P.Q.

- Volume 1. Orderly book. Regimental orders for the Royal Quebec Volunteers, Dec. 21, 1837- Apr. 8, 1838.
 Also contains drafts of 4 letters written in 1852 by Archibald McKillop concerning a church controversy in Inverness township.
- Volume 2. An account book of expenses for a company of loyal militia, kept during the Lower Canada Rebellion for the first months of 1838. Many of the accounts are signed by the soldiers involved.
 Eight pages are devoted to Archibald McKillop's spiritual state, 1851-1864.
 Several scattered pages personal accounts and church accounts and statistics
- Volume 3. Minutes of the meetings of Inverness township council, 1841-43.
 An account of the death of the writer's daughter's death, 1842.
 An account of the granting of a piece of land to the Presbyterians by Archibald McKillop and subsequent complications.
 Draft of a letter to the Quebec Gazette.
 The back pages form an account book of the Royal Quebec Volunteers. Many accounts signed by the soldiers.

- Volume 5. Letter book, chiefly in German, some in French.
