**TYMPERON MOTTRAM FAMILY PAPERS**

Ten pieces relating to the Tymperon and Mottram families.

Henry Tymperon (d. Oct. 4, 1724), rector of Market Orton (Overton), Rutland, married firstly, Margaret Yonge, secondly, Margaret Mackworth.

By his second wife he had two daughters: Henrietta, who married John Mottram in 1718, and Mary, who married Henry Masters (Maister) in 1724. Maister died in 1744 (cf. A History of the County of York, East Riding, v. 2, p. 11 and index (DA\670\Y6H5)).

Henrietta and John Mottram had three daughters: Mary, Henrietta and Margaret. Margaret married Thomas Brackenbury and their eldest son was Charles.

Notes:

Burton Pidsea, Carnaby and Ulrome are in the East Riding of Yorkshire.

In A consolidated index to Paver's Marriage Licences (Yorkshire Archaeological Society, extra series, v. 2 (DA\670\Y59Y6)) the name is variously spelt: Timperon, Temperon, Tymperon.

- Folder 1      1649 Feb. 22. Indenture between Christopher Temperan of Carnaby, yeoman, of the one party, and Robert Barloe of Ulrum (Ulrome), husbandman, and Robert Daile of Carnaby, husbandman, of the other party. D.S. 1 leaf.
- Concerning the lease by Barloe and Daile of a cottage or tenement and lands owned by Temperan.
- Folder 2      1687 Dec. 29. "An account then made in full betwixt Liddea Tymperon and Bete Tymperon consarning there portions is as followeth ..."

- Folder 3      1699 Oct. 28. Obligation of Lydia Tymperon of Beverley, in the County of York, spinster, and Elizabeth Tymperon of Northrop, in the County of Lincoln, spinster, to pay John Tymperon of Middle Temple, London, the sum of 48 pounds with interest. D.S. 1 leaf.
- Latin bond with conditions in English. With note dated Oct. 26th 1702, stating that Lydia Tymperon paid 20 pounds "in part of a big bond".
- Folder 4      1716 Nov. 27. Petition of Henry Andrews (through John Brown) "To the Right Honoble William Lord Cooper Baron of Wingham Lord High Chancello<sup>r</sup> of Great Britteine" for redress against John Booth, John Mottram and Robert Boswell. D.S. 4 p.
- He "bids for the securing the repayment [of 400 pounds] thereof with interest ..." With transcription.
- Folder 5      [1718] Notes concerning Henrietta Tymperon's jointure.

- Folder 6      1723 Sept. 14. The last will and testament of Henry Tymperon of Market Orton (Overton) in the County of Rutland. D.S. 1 leaf.
- It leaves his lands and estates in Burton Pidsey (Pidsea) to his daughter and son in law, Henrietta and John Mottram, but the rents and profits thereof to his wife Margaret and daughter Mary. A "memorandum" on the verso bequeathes a further 25 pounds to John Mottram "to pay his fine for the copyhold at Burton".
- Folder 7      1723 Oct. 5. "Recepi de incumbente ibidem pro proc. synodal. &c. Dom. Archidiac. Northamptoniae debitis ..." Printed receipt completed in MS. 1 leaf.
- Signed: Richd. Reynolds.
- Folder 8      [1724?] Two drafts of the wording for Henry Tymperon's tombstone. 2 leaves.
- Folder 9      1727 Sept. 26. "B. Godfrey ... rec'd then by the hand of M<sup>r</sup> Henry Masters of M<sup>r</sup>. Mottron (Mottram) & M<sup>rs</sup> Temperon the summe of twenty five pounds in full for their fine by surrender to ye declaration of the uses of M<sup>r</sup> Henry Temperons will - for the use of Cuthbert Constable ... p[er] Robt. Brigham. D.S. 1 leaf.
- Folder 10     1781 Oct. 31. "Copy draft of Deed of Covenant to produce title deeds; with schedule." D.
- The securing of lands from Mary and Henrietta Mottram and Margaret Brackenbury (sisters) to Charles Brackenbury.
